## 1. Trustsphere-AI PRIVACY AND SECURITY POLICY

Trustsphere-AI ("we", "us", or "Trustsphere-AI") is an international business company registered in Saint Lucia under registration number: 2023-00068. #### 2. COMMITMENT

Trustsphere-Al is committed to protecting the privacy of all personal information obtained from you, including information collected during your visits to this website or the provision of other services to you. We will use your personal information in accordance with this Privacy and Security Policy and in compliance with the Privacy and Data Protection Act in Saint Lucia.

# 3. Trustsphere-AI COLLECTS PERSONAL INFORMATION

Trustsphere-Al collects certain personal information to meet the needs of its customers. By gathering personal information, we can monitor and improve the services we offer to both existing and potential customers. We will use this information for the following purposes: establishing and maintaining your account, providing our services, regulatory notifications, and marketing.

- To create anonymized statistical data.

You consent to Trustsphere-Al using your personal information for these purposes. You also consent to the transfer of your personal information outside of Saint Lucia where necessary for Trustsphere-Al to fulfill its contractual obligations to you. We only transfer personal data to organizations outside Saint Lucia that meet our privacy and security standards.

# 6. WHO MAY Trustsphere-AI DISCLOSE THIS INFORMATION TO?

Trustsphere-Al may be required to provide your personal information to regulators and government bodies as necessary. We may also disclose your personal information to:

- Financial institutions and similar organizations within the course of our corporate activities, or those you have nominated.
- External service providers and professional advisers (who may be located overseas) providing services to Trustsphere-AI.
- Any organization at your request, including your financial adviser, broker, solicitor, or accountant.
   Third parties where necessary to process a transaction or provide services you requested.
   Authorities to whom we are required to disclose information by law.

Please note that Trustsphere-Al does not sell or share your personal information with third parties for marketing purposes.

#### 7. UPDATING YOUR INFORMATION

You may inform Trustsphere-Al at any time of changes to your personal details or request the deletion of personal information we hold about you by emailing us at support@Trustsphere-Al.com We will update or delete

your information in accordance with your instructions, except where we are required to retain it for legal or regulatory purposes, to provide requested services, or to maintain business records.
